Our ability to complete supplemental recruitment activities during this period was severely hampered by the Covid-19 pandemic. Typically most of the activities that we participate in would take place between April and the end of the school year or over the course of the summer. Although we were scheduled to participate in several school activities they were all cancelled due to the pandemic. During the summer, we frequently have an individual complete an internship. This year, we weren't able to due this due to reduced staffing caused by the pandemic and to limit contact with individuals outside of our small group of employees for safety reasons. A portion of our sales team worked remotely and we enacted restrictions on visitors to the studios to create as safe an atmosphere as possible for those individuals required to maintain a physical presence at the station.

We are closely monitoring the situation surrounding the pandemic and will resume supplemental recruitment activities as soon as it is safe to do so.
